Good Governance and Big Data

What is the program about?

We live in a world where sizeable data about minutest behaviors of millions of individuals is recorded for a wide variety of purposes. Such copious amounts of data are often called 'big data'. This program will train you on how to use big data for good governance. More specifically, the program will follow a three-stage approach. In the first stage, you will get to know big data as a 'general purpose technology' that can be put to use across many domains. At this stage, we shall be concerned with questions like 'what is big data', 'why use big data', 'what are the coding skills needed to use big data', and 'what are the software and hardware capabilities required to effectively handle big data'.

In the second stage, you learn about specific applications of big data that have improved governance across India and other parts of the world. These applications come from domains as varied as the management of traffic flow, delivery of health and education services, flood control, climate change, and response to crime. We will note the state of affairs before the use of big data, how big data solved a domain specific problem, the challenges involved in using big data, and measurable change in outcomes that resulted from using of big data. We will also develop the managerial capabilities that are needed to create and lead a team of data scientists to solve problems of governance.

In the third stage, you will work on assignments in which you will use big data to solve a governance related problem. Our coders will provide you with technical support needed to process data, formulate algorithms, and generate solutions. This unique experience of working with coders will help you understand the challenges involved in translating 'a governance problem' into 'a problem that can be solved using big data'.

What are the learning outcomes?

- (1) You will be introduced to software and hardware capabilities that are needed to use big data.
- (2) You will learn how to build and manage a team of data scientists
- (3) You get to know specific examples of the use of big data in improving governance in India and other countries
- (4) You will use big data to solve a governance problem of your interest
