A Non-Technical Introduction To Financial Derivatives

September 18 - 20, 2025

Overview:

This is a three-day off-line course designed to introduce participants to the world of Derivatives. Over the past three decades, the market for financial derivatives has witnessed a phenomenal growth in terms of both turnover and sophistication. The objectives of this short course is to demystify this group of financial products and help participants appreciate the use of derivatives for either trading or hedging at an intuitive level. The sessions will also include a discussion on the basic role of derivatives in risk management through a case study.

Content

After introducing the participants to various players in the derivatives market, the specifics of trading will be discussed for derivatives products. The course will then move on to give a conceptual framework under which different kinds of derivatives can be treated under a single umbrella. The program will also cover an understanding of basic derivatives strategies to manage risk and some of the caveats that one should keep in mind while dealing with derivative contracts.

- Managers who work closely with their company's Finance department
- Managers who have something to do with Risk management in their organization
- Anybody who is curious to know more about this part of the financial world (if someone has already got a formal introduction to this topic during their college days, we suggest them to skip this introductory course and take an advanced course instead)
