PART-1: GENERAL INFORMATIONS AND INSTRUCTIONS FOR THE BIDDERS

A. INTRODUCTION

INDIAN INSTITUTE OF MANAGEMENT KOZHIKODE (IIMK) is one of the premier management institutes in the country set up by Ministry of Education, Govt. of India, offering widest range of academic programs in the field of management education. It is contributing to management education and developing human resources to meet requirements of India's economy and industries and is on a high growth trajectory today. Bids are invited from eligible and qualified persons/firms for *"Tender for* **Providing 60 Mbps Point to Point Leased Line Connectivity between IIMK & Kochi Campus"** for Indian Institute of Management Kozhikode. IIMK has a plan to install 60 Mbps Point to Point Leased Line Connectivity between IIMK & Kochi campus, First Floor, Software Development Block, Athulya IT Complex, Infopark, Kakkanad. This includes installation, commissioning, testing & up keep of the complete link for oneyear period, which may be extended further, based on the requirement of the Institute on yearly basis. The hardware and software required for the establishment of fully functional leased line will have to be provided by the bidder.

B. GENERAL INFORMATION

- 1. **Single-Bid system:** This bid is under single bid system through e-tendering, the Techno-Commercial Bid would be opened on the time and date mentioned in the NIT.
- 2. Last date and time for submission of the Bids: 15:00 Hrs. on 07.03.2024 : The bidder has to submit online bids i.e. Techno-Commercial Bid and Commercial Bid through e-procurement portal <u>https://mhrd.euniwizarde.com/</u>
- 3. Manner of submission of the Bids: Tenders are to be submitted online through the website stated above. The tender document may be downloaded from website & submission of technical bid, Price Bid as per Tender time schedule. No manual bid will be accepted.
- 4. **Time and date for opening of Bids:** The Techno-Commercial Bid will be opened electronically on **07.03.2024 at 16:00 hrs**. Bidders can witness electronic opening of bid.
- 5. Forwarding of Bids: Bids should be submitted by Bidders furnishing details like valid GST registration number, Bank account details with address and complete postal & e-mail address of their office.
- 6. Clarification regarding contents of the Bids: During evaluation and comparison of bids, the IIMK may, at its discretion, ask the bidder for clarification of his bid. The request for clarification will be given in writing and no change in prices or substance of the bid will be sought, offered or permitted. No post-bid clarification on the initiative of the bidder will be entertained.
- 7. **Rejection of Bids:** Canvassing by the Bidder in any form, unsolicited letter and post-tender correction may invoke summary rejection. Conditional bids will be rejected.

8. Validity of Bids: The Bids should remain valid till 120 Days from the last date of submission of bid.

C. INSTRUCTIONS TO BIDDERS FOR THE E-SUBMISSION OF THE BIDS ONLINE THROUGH E-PROCUREMENT PORTAL.

The bidders are required to submit soft copies of their bid electronically on the e-Wizard Portal using valid Digital Signature Certificates. Below mentioned instructions are meant to guide the bidders for registration on the e-Wizard Portal, prepare their bids in accordance with the requirements and submit their bids online on the e-Wizard Portal. For more information, bidders may visit the Portal (https://mhrd.euniwizarde.com/)

1. Registration Process on Online Portal

- a) Bidders to enroll on the e-Procurement module of the portal <u>https://mhrd.euniwizarde.com/</u> by clicking on the link "Bidder Enrolment".
- b) The bidders to choose a unique username and assign a password for their accounts. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. This would be used for any communication from the e-Wizard Portal.
- c) Bidders to register upon enrolment, with their valid Digital Signature Certificate (Class III Certificates with signing and Encryption key) issued by any Certifying Authority recognized by CCA India with their profile.
- d) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse.
- e) Bidder then logs in to the site through the secured log-in by entering their user
- f) ID/password and the password of the DSC / e-Token.
- g) After registration send mail to Helpdesk: <u>helpdeskeuniwizarde@gmail.com</u> for Account activation.
- h) As per portal norms Registration Fee will be applicable.

2. Tender Documents Search

- a) Various built-in options are available in the e-Wizard Portal like Department name, Tender category, estimated value, Date, other keywords, etc. to search for a tender published on the Online Portal.
- b) Once the bidders have selected the tenders they are interested in, they may download the required documents/tender schedules. These tenders can be moved to the respective 'Interested tenders' folder.
- c) The bidder should make a note of the unique Tender No assigned to each tender, in case they want to obtain any clarification/help from the Helpdesk.

3. Bid Preparation

- a) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- b) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid.

- c) Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that needs to be submitted. Any deviations from these may lead to rejection of the bid.
- d) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document/schedule and generally, they can be in PDF/XLSX/PNG, etc. formats.

4. Bid Submission

- a) Bidder to log into the site well in advance for bid submission so that he/she uploads the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- b) The bidder to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- c) Bidders to note that they should necessarily submit their financial bids in the prescribed format given by department and no other format is acceptable.
- d) The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, the opening of bids, etc. The bidders should follow this time during bid submission.
- e) All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data, which cannot be viewed by unauthorized persons until the time of bid opening.
- f) The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- g) Upon the successful and timely submission of bids, the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- h) The off-line tender shall not be accepted and no request in this regard will be entertained whatsoever.
- i) As per portal norms Tender Processing Fee will be applicable.

5. Amendment of Bid Document

At any time prior to the deadline for submission of proposals, the department reserve the right to add/modify/delete any portion of this document by the issuance of a Corrigendum, which would be published on the website and will also be made available to the all the Bidder who has been issued the tender document. The Corrigendum shall be binding on all bidders and will form part of the bid documents.

6. Assistance to Bidders

- a) Any queries relating to the tender document and the terms and conditions contained therein should be addressed to the Tender Inviting Authority for a tender or the relevant contact person indicated in the tender.

- c) The tender inviting authority has the right to cancel this e-tender or extend the due date of receipt of the bid(s).
- d) The bid should be submitted through e-Wizard portal (<u>https://mhrd.euniwizarde.com/</u>) only.

PART II: TERMS & CONDITIONS OF THE CONTRACT

1. Eligibility Conditions / Per-Requisite Qualifications

- a) The bidder should be a Telecom Service Provider having ISP Class "A"/ "B" / "C" and unified Access Service provider license from Department of Telecommunication. (Attach copy of license)
- b) ISP should be having their own last-mile connectivity on underground Fiber.
- c) The agency/firm must have a minimum of 5 years of experience in providing similar connectivity and should have the necessary infrastructure. Minimum of 5 or more customers to be provided. (Attach proof)
- d) The firm/agency must have a fully functional Customer Service Center(s) in Kochi region, which is fully operational 24x365 days. List of Customer Service Center(s) must be enclosed with technical bid. (Attach proof)
- e) The firm/agency have adequate bandwidth at the backend to provide the desired bandwidth in Institute. Supporting document must be enclosed with technical bid. (Attach proof)
- f) The proposed link is for increasing the redundancy in the existing leased line connectives. The offer from the existing service providers or who is sharing the infrastructure with existing providers at IIMK will not be considered.
- g) The bidder should not have been debarred and/ or blacklisted by any Central Government / or any State Government/Autonomous Department(s)/Body consecutively during the last three completed financial years. The affidavit should be submitted.
- h) The Bidder must have a valid PAN Number and GST registration. Copy of proof to be submitted.

2. ISP's Responsibilities:

- a) Providing, laying, Commissioning and testing of the end to end OFC (underground) links to specified location in the IIMK campus.
- b) Providing the **60 Mbps Point to Point Leased Line Connectivity between IIMK & Kochi Campus** at all the time throughout the contract period.
- c) Termination of the link at above premises on an Ethernet Port which will be connected to institute UTM.
- d) Providing dedicated ports on ISP's router.

- e) Providing dedicated Internet bandwidth as mentioned above.
- f) Unlimited Internet access through the dedicated port.
- g) 99.50% uptime guarantee for the link.
- h) Reports for performance, monitoring / usage to be submitted by the ISP on monthly basis or as per requirement of the Institute.
- i) Provide all customer premises equipment required, if any, and maintain the same at no extra cost (ISP should conduct a site survey before the submission of tender if needed at ISP's own expense).
- j) ISP should clearly specify any remote end equipment required to be provided by the Institute
- k) Local Maintenance of link.
- l) 24x7 help desk facility.
- m) 24x7 Network Monitoring.
- n) Responsible to maintain and monitor the last mile connectivity on 24x7x365 basis.
- o) The Service Provider would insure that the local loop provisioning does not violate any regulations as laid by Government of India / TRAI in respect of such links / networks
- 3. The bidders are advised to submit the desired papers/documents with their technical bids. Organizational Profile, failing which the bids shall be declared un-responsive.
- 4. **Non-Blacklisting Declaration Form:** Bidders are required to fill the Non-Blacklisting Declaration Form as per given in **Appendix-B** in the bid documents.
- 5. Security Deposit & Agreement: Within 15 (fifteen) days of the receipt of notification of award/Letter of Intent, the successful bidder shall furnish a Security Deposit equivalent to an amount equal to 3% of the Contract value, in the form of Demand Draft/Fixed Deposit Receipt/Bank Guarantee from any scheduled Bank. The Security Deposit shall be kept valid for a period of 14 Months. The deposit amount shall be payable without any condition what so ever and these guarantee shall be irrevocable. The Performance Guarantee /security deposit is intended for securing the performance of the entire tenure of the agreement between IIMK and the Contractor. The Performance Guarantee/Security Deposit shall be released only on satisfactory performance of the terms of agreement between the vendor and IIMK for the entire period of the agreed time frame plus two months. The deposit will not bear any interest.

The Performance Guarantee/Security Deposit is liable to be forfeited, if the party fails to execute the work as per the terms and conditions of the agreement and to the satisfaction of IIMK or on account of any breach of the agreement.

Within four weeks from the date of acceptance of the order by the selected Bidder, the Bidder shall execute an Agreement on non-judicial stamp paper of appropriate value (Rs200/-) with IIMK at Kozhikode in a format to be mutually agreed between IIMK and the selected Bidder.

- 6. The bidder must attach self-attested copies of its Bank Account, PAN, GST number, Certificate of incorporation/registration.
- 7. **Delivery Schedule:** The time allowed for commencing of services is 45 days reckoned from the day of issue of Work order.
- 8. **Penalty:** If the selected Agency fails to deliver the entire items within the stipulated date & time, a penalty @ 0.5% per week of the total order value with maximum limit of 5% as penalty and the actual cost paid to an outside agency by the IIMK for the desired items, shall be deducted from the firm's pending bills.
- 9. **Prices:** The rates quoted shall be inclusive of all admissible taxes/Duties/ Levies. Any increase in taxes and others statutory duties/levies after the expiry of scheduled delivery date or award of contract/work order shall be to the supplier account. However, benefit of any decrease in these taxes/duties shall be passed on to the IIMK by the supplier.
- 10. **Payment Terms**: 100% of the Onetime installation & commissioning charges shall be paid after the uplink of the connectivity, on submission of uplink connectivity test repot. Annual Recurring (bandwidth) charges shall be payable on quarterly basis at the end of each quarter, for which the Service Provider will raise the bill at least two weeks in advance before the end of each quarter.
- 11. Bidders will be disqualified/blacklisted from bidding for any contract with the Institute for a period of one year from the date of notification of bid if the bidder is found to be in breach of any bid terms & conditions/ Contract Order.

PART III: STANDARD CONDITIONS OF CONTRACT

- 1. Authorized signatory: If the tender is made by or on behalf of a company incorporated under the Companies Act of 1956, it shall be signed by the Managing Director or one of the Directors duly authorized on that behalf. If it is made by a partnership firm, it shall be signed with co-partnership name by a member of the firm who shall sign copy of Power of Attorney with the tender authorizing him to sign on behalf of the partners. A certified copy of the registered partnership deed shall also be submitted along with the tender.
- 2. The vendor should attach a list of his/her customers with supporting documents, failing which the tender is liable to be rejected.
- 3. LAW: The Work Order and agreement shall be considered and made in accordance with the laws of the Republic of India. The work Order shall be governed by and interpreted in accordance with the laws of the Republic of India.
- 4. Effective date of the contract order: Normally the contract shall come into effect on the date of its acknowledgment by the bidder (Effective Date) and shall remain valid until the completion of the obligations of the parties under the contract. The delivery, supply and performance of the services shall commence from the effective date of the contract Order.

- 5. **Dispute resolution:** All disputes or differences arising out of or in connection with the Work Order shall be settled by bilateral discussions. Any dispute, disagreement or question arising out of or relating to the Work Order or relating to Delivery of Computers, which cannot be settled amicably, shall be referred to the Director, IIMK whose decision shall be final and binding on both parties. The Agreement shall be governed by laws of India and court at Kozhikode shall have exclusive Jurisdiction.
- 6. **Dispute Resolution Board:** Either party aggrieved by the decision of the Director IIMK may refer the dispute before Dispute Resolution Board. Dispute Resolution Board shall consist of a presiding officer as mutually agreed by both parties failing which will be nominated by the Director IIMK. The said Board may resolve the dispute as per procedure evolved by it however subject to compliance of principle of natural justice. Advocates are not allowed to participate in the proceedings before the Board and both parties shall be represented by their full time officers. The decision/order passed by the board shall be final and binding on both parties. The cost of proceedings will be borne by the both parties.
- Penalty for Use of Undue Influence: The bidder shall undertake that he has not given, 7. offered or promised to give, directly or indirectly, any gift, consideration, reward, commission, fees, brokerage or inducement to any person in service of IIMK or otherwise in procuring the work Orders or forbearing to do or for having done or forborne to do any act in relation to the obtaining or execution of the present Work Order or any other work order with the Government of India for showing or forbearing to show favor or disfavor to any person in relation to the present work Order or any other work Order with the Government of India. Any breach of the aforesaid undertaking by the bidder or any one employed by him or acting on his behalf (whether with or without the knowledge of the bidder) or the commission of any offers by the bidder or anyone employed by him or acting on his behalf, as defined in Chapter IX of the Indian Penal Code, 1860 or the Prevention of Corruption Act, 1986 or any other Act enacted for the prevention of corruption shall entitle IIMK to cancel the work Order and all or any other work Orders with the Bidder and recover from the Bidder the amount of any loss arising from such cancellation. A decision of IIMK or the nominee to the effect that a breach of the undertaking had been committed shall be final and binding on the Bidder. Giving or offering of any gift, bribe or inducement or any attempt at any such act on behalf of the Bidder towards any officer/employee of IIMK or to any other person in a position to influence any officer/employee of the IIMK for showing any favor in relation to this or any other Work Order, shall render the Bidder to such liability/penalty as IIMK may deem proper, including but not limited to termination of the Work Order, imposition of penal damages, forfeiture of the Bank Guarantee and refund of the amounts paid by IIMK.
- 8. Access to Books of Accounts: In case it is found to the satisfaction of IIMK that the bidder has engaged an Agent or paid commission or influenced any person to obtain the contract as described in clauses relating to Agents/Agency Commission and penalty for use of undue influence, the bidder, on a specific request of IIMK, shall provide necessary information/ inspection of the relevant financial documents/information.
- 9. Non-disclosure of contract documents: Except with the written consent of the IIMK/Bidder, other party shall not disclose the contract or any provision, specification, plan, design, pattern, sample or information thereof to any third party.

- 10. **Termination of contract**: The IIMK shall have the right to terminate this contract in any of the following cases without payment of compensation:
 - a) The successful Bidder is declared bankrupt or becomes insolvent.
 - b) The IIMK has noticed that the successful bidder has utilized the services of any Indian/Foreign agent in getting this contract and paid any commission to such individual/company etc.
 - c) For non-performance/default in compliance of the terms and conditions of the contract.
- 11. IIMK may terminate this contract at any time with the notice of 30 days in advance.
- 12. Notices: Any notice required or permitted by the contract shall be written in the English language and may be delivered personally or may be sent by registered pre-paid mail/airmail, addressed to the last known address of the party to whom it is sent.
- 13. **Transfer and Sub-letting:** The Bidder has no right to give, bargain, sell, assign or sublet or otherwise dispose of the Contract or any part thereof, as well as to give or to let a third party take benefit or advantage of the present Contract or any part thereof.
- 14. **Amendments:** No provision of present Contract shall be changed or modified in any way (including this provision) either in whole or in part except by an instrument in writing made after the date of this Contract and signed on behalf of both the parties and which expressly states to amend the present Contract.
- 15. **Contract period:** The contract period for providing the Internet Leased Line Connectivity to Institute would be initially for **one year** and may be further extended for two more years, based on the requirement of the Institute on yearly basis, else the contract will stand canceled on expiry of contract or after a written notice of 30 days.

The agreed price would be applicable throughout the contract period. No hike in price would be admissible; however, if the prices are reduced on any account, benefit of the same should be passed on to Institute.

- 16. **Unsatisfactory performance:** IIM Kozhikode shall have the sole and discretionary right to assess the performance(s) of the Bidder components(s), either primary and or final, and IIM Kozhikode, without any liability whatsoever, either direct or indirect, may reject the service provided by the Bidder, in part or in its entirety, without needing to offer any explanation to the Bidder, either during the pre and or post test period should the same be unsatisfactory and not be to the acceptance of IIM Kozhikode. The Bidder covenants to be bound by the decision of IIM Kozhikode without any demure in such an eventuality.
- 17. **Commencement of contract:** The Service Provider shall commence the work from the date of receipt of acceptance of the Letter of Intent (LOI)/work order which shall be accepted by the Service Provider within not more than 10 days from the receipt of the Letter of Intent (LOI)/Work Order.
- 18. **Service Level Agreement:** ISP or authorized person from ISP will be required to sign Service Level Agreement.

- a) Network Availability: More than 99.50 % per month.
- b) Latency: Less than 100 ms from ISP's tier 1 peering point
- c) Packet Losses: Less than 1 % (Average over 1000 ping) at any given point of time to any part of Country / ISP Internet gateway.
- d) Network Availability (uptime): More than 99.50 % per month.
- e) Reports for performance, monitoring / usage to be submitted by the ISP on monthly basis or as per requirement of the Institute.
- f) Downtime Calculation: Downtime shall be calculated as (Total Time Down Time) X 100/Total Time. Deduction in payment will be made for downtime in the quarterly bills raised by the ISP.
- g) The response time for attending the faults will be 1 hour after they are reported to the ISP. The ISP will rectify the faults within 12 hours failing which; the vendor will arrange temporary replacements. The services shall be provided 24 X 7 days in a week.
- h) Reports for performance, monitoring / usage to be submitted by the ISP on monthly basis or as per requirement of the Institute.

i) Downtime penalty in % of monthly payment:

- J) Downtime due to the following situations will not be considered for the purpose of penalty:
- (i) Link down due to power failure / or any situation which are beyond the control of service provider.
- (ii) Due to schedule maintenance by the Service Provider, with prior approval of Institute.
- (iii) Mean Time to Repair (MTTR), Packet loss and Link failover will be calculated from Network Management System (NMS) installed at Institute side or through ISP portal.
- 19. The Bidder is required to give confirmation of their acceptance of the Standard Conditions of the Contract, which will automatically be considered as part of the Contract concluded with the successful Bidder as selected by the IIMK. Failure to do so may result in rejection of the Bid submitted by the Bidder.

PART IV: PREPARATION OF BID DOCUMENT

1. The Bidder is expected to examine all instructions, forms, terms and specifications in the Bid Document. Failure to furnish all information required as per the Bid Documents or submission of the bids not substantially responsive to the Bid Documents in every respect will be at the bidder's risk and shall result in rejection of the bid. - 2. All pages of the Bid Document must be signed by the authorized signatory and sealed with the stamp of the bidding firm as token of having accepted all the Terms and Conditions of this Bid
