- 4. Delivery schedule shall clearly be indicated. IIMK shall impose penalty for delayed delivery @0.5% per week or part thereof, subject to a maximum of 2.5%
- 5. Normal payment term acceptable to IIMK is that the bills shall be cleared within 20 days from the date of satisfactory delivery of the items.
- 6. The quoted items shall be delivered at IIMK campus Nursery or other locations in IIMK as identified by the IIMK official within seven days of receiving the supply order.
- 7. The acceptance of quotations shall rest with the Institute which does not bind to accept the lowest quotation and reserves to itself the authority to reject any or all of the Quotations received without assigning any reason.
- 8. Institute may award the contract for the lowest bidder in each item asper the discretion of the Institute.
