- 1. The following amendments are made in the Request for Proposal cited under Ref(1) above, regarding "Implementation and Support of Enterprise Resource Planning (ERP) Solution at IIM Kozhikode":-
 - (a) The date of submission of the RFP is extended as under :-

(i) Deadline for Submission of Request for Proposal : 07.10.2021 till 3.00 pm

(ii) Date of Opening of RFP (Technical Bid) : 07.10.2021 at 4.00 pm

(b) Page No 11, Section 1.6 (3.) under 'ERP Licensing'

3. The licenses offered should be for a cloud based ERP System. The cloud ERP should be scalable and have provision to build customization custom process and innovation.

Read

3.1 The licenses offered should be for a cloud based ERP system. The Cloud ERP should be scalable and have provision to build customization custom process and innovation. The cloud solution offered has to be either in Platform as a Service model (PaaS) or a combination of PaaS and Software as a Service model (SaaS) model. The SI has to submit references of ERP system proposed to IIMK

running in the proposed cloud service providers system. IIMK reserves the right to accept or reject the cloud service provider proposed.

- 3.2 For the PaaS model SI has to include the details of Cloud System, Solution, Architecture, Cloud Service provider and their SLAs in the technical bid. The annual subscription cost and all other cost related to cloud hosting for PaaS component to be included in the SI's Price Bid. The details of licenses, solution and other details to be included in the BOQ for OEM and to be shown in the Technical bid.
- 3.3 For the SaaS component, if any the SI has to mention the SaaS details in BOQ of OEM, along with solution architecture, module details, etc
- 3.4 For both SaaS and PaaS options the Cloud Server and data should reside in India.
- (c) Page No 12, Second Para, under 'ERP Licensing'

Based on the recommended ERP package, Bill of Quantities (BOQ) and Solution architecture, IIMK shall procure the ERP Software license and Annual Technical / Service Support directly from the ERP OEM. The BOQ, solution architecture, user license, tools for development, tools for integration which is to be procured from OEM for this implementation to be shown in a separate sheet in the technical bid.

Based on the recommended ERP package, Bill of Quantities (BOQ), Service model (PaaS or combination of PaaS and SaaS) and Solution architecture, IIMK shall procure the ERP Software license and Annual Technical / Service Support directly from the ERP OEM. The BOQ, solution architecture, user license, tools for development, tools for integration which is to be procured from OEM for this implementation also to be included. In case the proposed solution is a combination of SaaS and PaaS model then the BOQ for PaaS and SaaS have to be clearly mentioned. All these items to be shown in a separate sheet in the technical bid

5. The SI shall be responsible for the installation, configuration, customization, integration, testing, data migration and deployment of the proposed system. It is suggested to make minimal changes to the standard modules to ensure that future upgrades, enhancements

and bug fixes are done without any complexity. Every customization to the system must be documented in detail and the code/script should be properly annotated with comments.

- 5. The SI shall be responsible for the installation, configuration, customization, integration, testing, data migration and deployment of the proposed system for the PaaS component. For the SaaS component, if any, then installation and initial configuration will be in OEM's scope and all the other activities will be in SI's scope. SI should coordinate with OEM for smooth integration and functioning of the system. It is suggested to make minimal changes to the standard modules to ensure that future upgrades, enhancements and bug fixes are done without any complexity. Every customization to the system must be documented in detail and the code/script should be properly annotated with comments.
- (e) Page No 209. Annexure IV: ERP Implementation Price Bid has been revised.
