**Sub:** Additions/Amendments - Tenders for “Selection of Agency for Providing Facility for Conducting Online Examinations with Remote Proctoring for IIM Kozhikode”

1. The date of submission of the tender cited under reference above is extended as under:-

**Period of downloading of Bid document : Up-to 05.05.2022 till 02.00 pm**

**Last Date of Receipt of Bid : 05.05.2022 up-to 03.00 P.M**

**Date of opening of Bid : 05.05.2022 at 04.00 P.M**

2. The following additions/amendments are made in the paras as noted against each :-

(a) Para **3.2 (v)** [page 7] under heading Examination Portal is **revised** as under:-

“(v) The language used in the examinations is English only.”

(b) Add the following after Para 6.11 (c) [page 11] under heading Earnest Money Deposit.

“(d) Start Ups, Small and Medium Enterprises are exempted from payment of EMD”.

(c) Para **8 (e)** [page 15] under heading Pre-Qualification Criteria is **revised** as under:-

“(e) The bidder should have prior experience and executed similar works as under:-

(i) **One** similar work of Rs. 50 Lakhs.

OR

(ii) **Two** similar works of Rs. 40 Lakhs each.

OR

(iii) **Three** similar work of Rs. 25 Lakhs each”

(d) A new sub para **8 (g)** [page 15] under heading Pre-Qualification Criteria is **added** as under:-

“(g) Start Ups, Small & Medium Enterprises are permitted a relaxation in the criteria for Annual Financial Turnover and Prior Experience as under:-

(i) Annual Turnover of at least Rs. 25 Lakhs during the past three Financial years in Indian Operations.

(ii) Prior experience of executing similar works :-

(aa) **One** similar work of Rs. 30 Lakhs.

OR

(ab) **Two** similar works of Rs. 20 Lakhs each.

OR

(ac) **Three** similar work of Rs. 15 Lakhs each”

(e) A new sub **para 11 (f)** [page 17] under heading ‘Evaluation Criteria’ **is added** as under:-

“The Bidders who submit their Bids will be required to give a detailed presentation of not more than one hour duration, explaining the Features and Technical Solutions offered in the Product. The bidders may intimate their suitable dates on any working day (Monday to Friday) upto 10 May 2022.”

(f) At Annexure-III [page 20] under heading ‘Annual Turnover Details’, the **Four Years of Annual Turnover** to be provided **is amended** as under:-
