- 1. In case of exigencies, the Programme Committee may take certain academic decisions, that, if required, may be ratified in the subsequent meetings of the larger Academic Committees. Quorum for all Committees is 50% of the total number of members. In case the quorum is not achieved in any meeting, the Convenors may take important decisions that cannot be postponed, with the permission of the Chairperson of the respective Committees and the Director. However, the Director would be the final approving authority as per Delegation of Power and Functions of the Board, as per IIM Kozhikode Regulations.
- Notwithstanding the above, as per Regulations of IIMK to IIM Act 2017, the Chairperson of the Academic Council (the Director) may constitute such Sub-committees of Academic Council/Programme Committees for specific purposes as and when required. The Chairperson of Academic Council may accept in full or in part any of the recommendations of Academic Council or such sub-committees of Academic Council/Programme Committees.
