# BGM 92.17 IIMK Faculty Closure of Probation and Confirmation - Guidelines

We have received applications from faculty requesting for confirmation after serving the period of probation. These applications are recommended for closure of probation and confirmation after an assessment of the faculty's performance during the period of probation. It is important that we follow a consistent process and criteria for assessment of the faculty's performance during the probation period. The following process is recommended for processing the probation requests to be strictly followed by the Dean (AA&D)'s office.

- 1. Faculty completing the period of probation will be requested to submit a detailed activity report providing details of the contributions and achievements in teaching, research and other institutional work during the probation period.
- 2. The activity report has to be accompanied by an updated resume and copies of documents to support the claims including published papers, teaching feedback etc. It is also required that the faculty must have submitted all the mandatory appraisals and reports in time.
- 3. The applications will be processed by Dean (AA&D)'s office based on the information available in the activity report, quarterly self-appraisals, annual activity reports and other information and documents available in the institute and programme offices.
- 4. The faculty member will be assessed on a five-point scale on three performance criteria namely Teaching, Research and Institutional Contribution.
- 5. The recommendation for confirmation will be based on the faculty meeting the following requirements.

The faculty has to earn a minimum rating of 3 (indicating moderate or average attainments) on all the three parameters. In addition, the following minimum ratings will apply.

- Professor: Four or above in at least two criteria and Five in at least one criterion.
- Associate Professor: Four or above in at least two criteria.
- Assistant Professor: Four or above in at least one criterion.

In case, the faculty is still not able to meet the requirements despite the extended time, the faculty will be reverted to the earlier position but not lower than the entry cadre.

As per the IIMK Faculty Closure of Probation and Confirmation guidelines approved by the BoG in its meeting held on 17.10.2020, the faculty on probation have to be evaluated in multiple areas of teaching, research and institutional contribution. The present probation period of one year found to be insufficient to evaluate the latest prescribed criteria. Therefore, it is proposed that the probation period may be increased to two years from the existing one year.

In case performance during probation is not satisfactory, the period of probation may be extended by another one-year subject to maximum of two such extensions. i.e., maximum probation period will be four years in a particular case. The above condition will apply to both new recruitment as well as in the case of selection/ promotion.

After the maximum probationary service of four years, non-performers shall not be absorbed in to the services to which they have been appointed and they may be discharged from the Institute following due procedures. However, if the non-performing faculty is appointed by promotion, such faculty may be reverted back to the earlier position in which the faculty holds a lien.
