BGM 96.13 Proposal for cancellation of interview as part of selection process for posts up to Pay Level 9

Background:

As per Government of India order No. 39020/01/2013-Estt.(B) dated 29.12.2015, interview for all Group 'C' and 'D' posts and non-Gazetted posts of Group 'B' category has been dispensed. Accordingly, those cases where recruitment rules of above categories of posts specify the process of selection through interview, the authorities concerned are required to amend the recruitment rules.

Proposal:

In view of the above, it is proposed to make the following changes in the IIMK Recruitment Rules 2019 -
