4. After online submission, candidates should take a print-out of the application form. This application form (print-out) duly accompanied by self-attested copies of driving license, experience certificate, mark sheets & certificates of educational qualifications, etc. should be produced at the time of document verification. Original certificates should also be furnished for verification purpose.
5. Application without signature, or incomplete in any other aspect will be summarily rejected.
6. Canvassing in any form and/or bringing in any influence, political or otherwise will automatically disqualify the candidate for the post.
7. Maximum age limit is 40 years as on date of notification. Age relaxation as per Government of India norms will apply on production of relevant certificates at the time of interview.
8. The engagement to the above post will be purely on contractual basis and selected person will have no right/claim for continuation or regular appointment.
